Submission of Public Paths Order

Hollingbourn Rural District (Hollingbourn No. 1) Public Paths Extinguishment Order, 1963

Notice is hereby given that the above Order was made on the 5th day of September 1963, and is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to extinguish the following lengths of public rights of way:

(a) A length of footpath commencing at a point on the Pilgrims Way approximately 217 yards north-west of its junction with the road leading to Maidstone, abutting the north-western boundary of the property known as "Lime Trees", and running in a south-westerly direction for a distance of approximately 187 yards.

(b) A length of footpath commencing at a point on the Pilgrims Way approximately 217 yards north-west of its junction with the road leading to Maidstone, abutting the north-western boundary of the property known as "Lime Trees", and running in a south-south-westerly direction for a distance of approximately 143 yards.

(c) A length of footpath commencing at a point on the north-western boundary of the property known as "Manorfield", Pilgrims Way, and running in a westerly direction for a distance of approximately 140 yards.

CWMBRAN URBAN DISTRICT COUNCIL

Highways Act, 1959

Notice is hereby given that on the 3rd day of October 1963, at 10.30 in the forenoon, the Urban District Council of Cwmbran will make application to Her Majesty's Justices of the Peace assembled in Petty Sessions at the Magistrates Court, Caerleon in the county of Monmouth, for an Order that a certain public highway in the Parish of Llantarnam in the said county forming part of a road known as Abbey Road, Cwmbran aforesaid, and leading from Commercial Street to Llandowlais Street, Cwmbran aforesaid, shall be diverted and turned and in parts stopped up in the following manner, that is to say:

(1) To stop up the said Abbey Road to vehicular traffic from a point some one hundred feet to the south of its junction with Belle Vue Road to a point some three hundred and fifteen feet to the south of the said junction;

(2) To divert vehicular traffic from Commercial Street, Cwmbran aforesaid, at the junction of Abbey Road and Belle Vue Road, Cwmbran aforesaid, along Belle Vue Road, Cwmbran aforesaid, thence along an extension of Belle Vue Road to a junction with Henllys Way, Cwmbran aforesaid, thence along an extension of Henllys Way Cwmbran aforesaid and a road leading from Henllys Way to Abbey Road aforesaid.

Plans of the proposed stopping up and diversion are deposited at the Council Offices, Cwmbran aforesaid and may be inspected without payment during the usual office hours.

On the hearing of the application, any person to whom notice of the application is required to be given under paragraph (1) of the 12th Schedule of the Highways Act, 1959, any person who uses the said highway and any other person who would be aggrieved by the making of the Order to be applied for, shall have the right to be heard.
