

*Town and Country Planning Act, 1962**Whitefield, Lancs*

The Minister of Transport hereby gives notice that he proposes to make an Order under section 153 of the above Act authorising the stopping up of a length of Oak Lane, the whole of Bent Lane and lengths of two footpaths on the Manchester Overspill Housing Site at Whitefield, Lancashire, in order to enable residential development to be carried out in accordance with planning permission granted to Manchester C. & C.B.C. by Whitefield U.D.C. and by Lancashire C.C.
