### HIGHWAYS ACT 1959

*The Northfleet (New Barn) Public Path  
Extinguishment Order 1963*

Notice is hereby given that the Minister of Housing and Local Government, in pursuance of the powers conferred upon him by section 112 of the Highways Act 1959, after consultation with the Northfleet Urban District Council proposes to make an Order for the extinguishment of the footpath at Northfleet (New Barn) in the county of Kent.

The draft Order relates to land situate at Northfleet (New Barn). The effect of the Order will be to extinguish the public rights of way, leading from a

point on the southern side of Longfield Avenue, east of a dwellinghouse known as "Cherrycot," Longfield Avenue, marked "A" on the map and running in a generally southerly direction for a distance of approximately 245 yards to a point marked "B" on the map near the southern end of Poplars Close.
