- (e) certain fish products to which a special accelera-tion of the reduction of the E.F.T.A. rate of duty applied consequent upon an undertaking given to Norway (see Schedule 3, Part III);
- (f) whale meat which by its deletion from Annex E to the Convention falls within the scope of the undertaking to Norway (see Schedule 3, Part IV).

The Import Duty Drawbacks (No. 11) Order 1963. This Order:

- (a) provides for the allowance of drawback of import duty for imported microphones of approximately rectangular shape with a maximum dimension not exceeding 20 mm. exported incorporated in complete deaf aids:
- (b) provides for the allowance of drawback of import duty for certain imported pasteurised spray-dried egg yolk used in the manufacture of exported preparations used for making cakes or buns or used to coat foodstuffs before frying;

- (c) revokes the existing provisions for the allow-ance of drawback of import duty on:
 - (i) certain stoned cherries used in the manufacture of preserved cherries,
 - (ii) soya beans used in the manufacture of fish, canned in soya bean oil,
