The QUEEN has been graciously pleased, on the advice of Her Majesty's Canadian Ministers, to give Orders for the following appointment to the Most Excellent Order of the British Empire:

To be an Additional Member of the Military Division of the said Most Excellent Order, for Gallantry:

ZD 7810 Lieutenant Joseph Terrence Francis Anthony LISTON, Royal 22e Regiment, Canadian Army.

On 12th January 1963 at Kabongo Lieutenant Liston was serving as a United Nations Liaison Officer with a Congolese Patrol. A Sergeant of the Patrol, crossing a grassy area, stepped on an anti-personnel mine which detonated, injuring himself and two others. On his arrival Lieutenant Liston found that two of the injured had been rescued, but the Sergeant was still inside the mine field, which he had penetrated further than the others. Using a bayonet as a probe, Lieutenant Liston found and marked three mines. He gallantly made his way twelve yards into the mine field, reached the injured man and, aided by a Congolese soldier, carried him out of the danger area. The courageous and effective action taken by Lieutenant Liston was in the best tradition of the Canadian Army.
