

with his Grace at his Lodgings, where he had another Conference with them this Evening. To morrow his Grace intends to set out for Hanover, and thence to Saxony, to meet the King of Sweden. Monsieur d'Amsterdam went from hence this Day for Brussels. The Troops which were quartered along the Meuse are marching towards Brussels, and will be quartered between that City, Mechlen and Louvain, from whence they are shortly to march towards Flanders, our main Army being to rendezvous on that side. The French Troops have been in motion towards Namur; but ours being every where upon their Guard, the Enemy did not think fit to make any Attempt. They work very hard upon their new Lines, and are getting together all the Provisions they can to store their Magazines at Mons, Douay and Tournay. Our Advices from those Parts say, the Duke of Vendome arrived at Lille the 14th Instant, and would be at Mons the 16th. The States of Holland met the 13th, and among other Things have under Consideration the raising of 700000 Florins, to be advanced by way of a Loan, to the King of Spain, upon some of his Revenues in the Netherlands. Our Convoys for Lisbon, with Recruits and other Supplies for our Forces in those Parts, will sail with the next fair Wind. They write from Vienna, that it had been intimated to the States Minister there, That the Emperor would give no further Opposition to the continuing of the Bishop of Paderborn's Election to the See of Munster, but would leave that Matter wholly to the Pope's Determination. Letters from France give an Account of a great Insurrection in Quercy, where the Inhabitants, not being able to bear any longer the heavy Burthen of the Taxes laid upon them, had taken up Arms; That their Numbers were increased to 20000; That they had seized a Convey that was sending to Spain, which had help'd to furnish them with Arms and Ammunition; That they had in a manner block'd up the Town of Cahors; and that some Troops designed for Spain had been countermanded, in order to their being employ'd to suppress this Insurrection. These Letters add, That they had an Account from Spain, that the Confederate Troops were march'd into Castile by the Way of Requena; and the Duke of Berwick, with the French and Spanish Forces under his Command, was observing them, the River Gabriel being between the two Armies. They write from Dauphine, That the Garison of Milen arrived the first Instant at Sale; and that the Prince of Vaudemont and the Count de Medavi were come to Chaumont, which was appointed to be the Head Quarter of the Enemy's Troops that were retiring out of Italy. Since the late Attempt made by the Party from Aeth, under the Command of Colonel Guethem, the Dauphin's Guards have been doubled. They write from Saxony, That King Augustus had delivered up General Patkul to the King of Sweden.

Whitehaven, April 7. Yesterday about 10 Sail of light Colliers came in here from Dublin. Our outward bound Virginia Men, to the Number of 23 Sail, are put to Sea.

Portsmouth, April 10. Yesterday in the Afternoon came to Spithead two Dutch Privateers, who brought in with them three French Prizes which they had taken.

Dedde, April 12. On the 10th Instant sailed hence Her Majesty's Ship the Flamborough for the River, and several Merchant-men to the Westward: The same Day came into the Downs the King William, --- Winter Master, and the Pearl Galley, --- Keeble Master, both from Leghorne; and the Countess, --- Gill Master, from Oporto. The 11th sailed hence to the Westward the Mascell and Martin Gallies, with the Bucephalus and Neptune Sloop. This Morning came in here the Ridge Galley, --- Davison Master, and the Hanover Galley, --- Bayley Master, both from Leghorne.
