*Swanage*

The Minister of Transport hereby gives notice that he has made an order under section 153 of the above Act entitled "The Stopping up of Highways (County of Dorset) (No. 1) Order, 1964" authorising the Stopping up of a footpath at Northbrook Road, Swanage and requiring the provision of a new footpath and a new road.
