### **BILLS RECEIVING ROYAL** ASSENT

This day the Lords being met, a message was sent to the Honourable House of Commons, by the Gentleman Usher of the Black Rod, acquaining them that The Lords authorised by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to the Acts agreed upon by both Houses, to desire the immediate attendance of the Honourable House in the House of Peers to or the Honourable House in the House of Peers to hear the Commission read, and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to:

Post Office (Borrowing Powers) Act 1964. (c. 3.)

#### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday the 14th February 1964, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £200,000,000. 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 17th February 1964 to Saturday

the 22nd February 1964, inclusive. and will be due 91 days after date. 3. The Bills will be issued and paid at the Bank

Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different

Notification will be sent by post on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part and pay-ment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not lear than 130 pm (Saturday Bank of England not later than 1.30 p.m. (Saturday 11.30 a.m.) on the day on which the relative Bills are to be dated. 7.
