

TYNEMOUTH COUNTY BOROUGH COUNCIL

The County Borough of Tynemouth (Brewhouse Bank) (Prohibition of Waiting) Order, 1964

Notice is hereby given that the Council of the County Borough of Tynemouth propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which will be to prohibit (with certain exceptions) the waiting of vehicles on Brewhouse Bank, North Shields, (a) on the East side for a distance southwards of 77 yards from opposite its junction with Bird Street and (b) on the West side for a distance southwards of 30 yards from its junction with Bird Street.

The exceptions referred to will enable a vehicle to wait as long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, or to enable the vehicle to be used in connection with any funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

FAREHAM URBAN DISTRICT COUNCIL

The Fareham Urban District (Portland Street Fareham) (Prohibition of Waiting) Order 1964

Notice is hereby given that the Fareham Urban District Council propose to make an Order under sections 26 and 27 of the Road Traffic Act 1960, the effect of which will be:

1. To revoke the Fareham Urban District (Portland Street) (Prohibition of Waiting) Order 1958 (which permitted limited waiting on the west side), and 2. To prohibit (subject to the exceptions specified in the Order) the waiting of vehicles between 8 a.m. and 10 p.m. in Portland Street, Fareham (both sides) from A.27 West Street to the junction with Gosport Road and Quay Street, Fareham.

The Order will contain the usual exceptions, in the standard form, to permit waiting for boarding or alighting, for loading and unloading of goods, and to enable use in connection with various special operations (building, maintenance of roads services, etc.) and use by vehicles in connection with funerals.

GLAMORGAN COUNTY COUNCIL

(Rhiw Road, Penrhiwfawr, Pontardawe) (Restrictions on Driving) Order, 1964

Notice is hereby given that the Glamorgan County Council have applied to the Minister of Transport for confirmation of an Order made by them under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which will be to prohibit, with certain exceptions, the driving of any vehicle the unladen weight of which exceeds two and a half tons on the unclassified road known as Rhiw Road, Penrhiwfawr, Pontardawe, from its junction with the Class III (175) Road near Capel Rhiwfawr to its junction with the Class III (174) Road, a distance of three hundred and fifty three yards.
