The London Traffic (Prescribed Routes) (Basildon) Regulations 1964 (S.I. 1964/137)

**PUBLIC HEALTH (IMPORTED FOOD)
REGULATIONS 1937 AND 1948**

The Minister of Agriculture, Fisheries and Food gives notice in pursuance of the above-named Regulations, that he hereby recognises the official certificate of which particulars are given in the Schedule hereto as showing

- (a) that the meat was derived from animals inspected ante and post mortem and passed in

accordance with criteria satisfactory to the Minister and

- (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat.

The certificate being in the form of a stamp, recognition will apply only if the stamp is clearly impressed on the meat or on the container containing the meat and has not in any other circumstances or on any other occasion been used as an official certificate.

The certificate hereby recognised revokes the certificate recognised on 21st February 1950 and the certificate recognised on 29th March 1938 insofar as the importation of meat from France is concerned.

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT, 1952

To: Miss ELEANOR I. JARRETT, c/o Ministry of External Affairs, Slater Terrace, Freetown, Sierra Leone.

Pursuant to section 275 (5) of the Customs and Excise Act, 1952, and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely an Austin A.40 saloon motor car, index number 100 ELA found in Finchley Road, London N.W.3, on 22nd January 1964 have been seized as liable to forfeiture upon the grounds that the said car, being goods chargeable with a duty of customs was in June 1962 removed from its place of importation, at Liverpool, without payment of that duty.

Whereby and by force of section 44 (a) of the Customs and Excise Act, 1952, the said goods are liable to forfeiture.

If you claim that the same goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a Solicitor in England who is authorised to accept service or process and to act on your behalf, in default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
