## BROMLEY BOROUGH COUNCIL

The Borough of Bromley No. 6 Smoke Control Order, 1964

Notice is hereby given that the Council of the Borough of Bromley, in exercise of the powers con-ferred on them by section 11 of the Clean Air Act 1956 on the 24th day of February 1964, made an Order entitled "The Borough of Bromley No. 6 Smoke Control Order, 1964", declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation. for confirmation.

Subject to the exemptions provided by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding \$10 unlease he proves that the emission of smoke was £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthra-cite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before 1st December 1964, or before a later date
