SUBMISSION OF PUBLIC PATH EXTINGUISHMENT ORDER

Highways Act, 1959

Welton Rural District (Footpath No. 24, Ingham)

Notice is hereby given that the above Order made on the 6th day of March 1964, is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to extinguish the public right of way running from a point on a bridleway known as Short Lane, Ingham, approximately 200 yards north of West End Caravan Site (point "A" on map) in a north-westerly direction across Field O.S. No. 25 for approximately 300 yards and thence in a northerly direction across Field O.S. No. 24 for approximately 230 yards terminating at its junction with the aforesaid bridleway known as Short Lane (point "B" on map). A total distance of approximately 530 yards.

A copy of the Order and the map contained therein has been deposited at and may be inspected free of charge at the Council Offices, 31 Clasketgate, Lincoln, between the hours of 9 a.m. and 5 p.m., during the next twenty-eight days.

Any objection or representation concerning the Order may be sent in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, before the 3rd day of April 1964, and should state the grounds on which it is made.
