

H.M. CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT, 1952

To: GRAEME DOUGLAS NICHOLL, c/o Noble, Lowndes & Partners, Ltd., Clifford House, Collyer Quay, Singapore 1, Malaysia.

Date 27th March 1964.

Pursuant to section 275 (5) of the Customs and Excise Act, 1952, and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and enactments amending those Acts, certain goods, to wit One Jaguar motor vehicle Chassis Number 101950 DN, Engine Number BG 3075-8, found on or about 27th February 1964, outside 65 Rutland Place, London S.W.7, have been seized as liable to forfeiture upon the grounds that on or about 16th May 1963 the said vehicle, being goods chargeable with a duty of customs, on importation into the United Kingdom was allowed to be delivered without payment of that duty on condition that the said vehicle would not be, nor be offered to be, lent, hired, sold, given away, exchanged or otherwise dealt with or disposed of by you, within a period of two years from 16th May 1963, and, the said condition has not been observed. Whereby and by force of section 257 (1) of the Customs and Excise Act, 1952, the said goods are liable to forfeiture.

If you claim that the same goods are not liable to forfeiture you must within month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in England who is authorised to accept service of process and to act on your behalf, in default of such

notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
