### TOWN AND COUNTRY PLANNING ACT, 1962

#### *Extinguishment of Public Rights of Way* *Battle Rural District Council*

Notice is hereby given that the Minister of Housing and Local Government, in exercise of his powers under section 155 of the Town and Country Planning Act 1962, proposes to make an Order extinguishing the public rights of way over that part of bridleway 14 running north-east from "St. Barnabas", New Lydd Road, Camber.

### TOWN AND COUNTRY PLANNING ACT 1962

#### *Extinguishment of Public Rights of Way* *Urban District Council of Northallerton*

Notice is hereby given that the Minister of Housing and Local Government, in exercise of his powers under section 155 of the Town and Country Planning Act 1962, proposes to make an Order extinguishing the public rights of way over parts of Tweddles Yard, Fleece Yard, Black Swan Yard, Flag Terrace and Claphams Yard, in the Urban District of Northallerton.

### HIGHWAYS ACT 1959

#### *Axbridge Rural District (The Slip, Congresbury)* *Public Path Diversion Order 1964*

Notice is hereby given that the Minister of Housing and Local Government, in pursuance of his powers under section 112 of the Highways Act 1959, after consultation with the Axbridge Rural District Council proposes to make an Order for the diversion of part of a footpath at Congresbury in the County of Somerset.

The draft Order relates to land situate at The Slip, Congresbury. The effect of the Order will be to divert part of the public right of way running between Kent Road and the Southlands Council Estate, which part starts at Kent Road, at the north-eastern corner of the property known as Hill Villa, and runs south-west for approximately 194 feet, to a line starting in Kent Road, at a point approximately 102 feet east of the commencement of the existing path, and running south first, by way of a flight of steps, then west, south and finally south-west for a total distance of approximately 110 feet to rejoin the existing path to the Southlands Council Estate.

A copy of the draft Order and of the map contained in it has been deposited at the offices of the Axbridge Rural District Council, Axbridge, Somerset and at the Ministry of Housing and Local Government, Whitehall, London S.W.1, and may be inspected during normal office hours.

### HIGHWAYS ACT 1959

#### *Uckfield Rural District (Footpath No. 35 Rotherfield (Part)) Public Path Diversion Order 1964*

Notice is hereby given that the Minister of Housing and Local Government, in pursuance of his powers under section 112 of the Highways Act 1959, after consultation with the Uckfield Rural District Council proposes to make an Order for the diversion of part of Footpath No. 35.

The draft Order relates to land situate in Rotherfield. The effect of the Order will be to divert the public right of way over part of Footpath No. 35 Rotherfield, which part starts at a stile, approximately 610 feet from the junction of the footpath with Yew Tree Lane, and runs north-west for approximately 320 feet across the garden of Rother Cottage, to a new line starting from the aforementioned stile; and running north, north-west and finally south-west along the eastern, northern and western boundaries of the aforementioned garden for approximately 411 feet.

### *Town and Country Planning Act 1962* *Selsey, Sussex*
