## MINISTRY OF LABOUR

### THE EXAMINATION OF STEAM BOILERS REGULATIONS 1964

#### *Factories Act 1961 (Appointed Day) Order 1964*

The Minister of Labour hereby gives notice that on 26th May 1964 he made the Examination of Steam Boilers Regulations 1964. The regulations prescribe the manner in which, and occasions on which, steam boilers in factories and other places to which the Factories Act 1961 applies are required to be examined in pursuance of section 33 (2) and (3). They will replace the transitional provisions relating to steam boilers contained in paragraph 3 of Schedule 6 to the Act, and are to come into operation on 27th June 1964.

On the same date he made the Factories Act 1961 (Appointed Day) Order 1964. The Order appoints 27th June 1964 as the day on which Part II of the Factories Act 1961 is to cease to be subject to the transitional provisions of the Act relating to steam boilers.
