## SUBMISSION OF PUBLIC PATH ORDER

*Borough of Guildford—Bannisters Farm Playing Field Public Path Diversion Order, 1964*

Notice is hereby given that the above Order made on the 8th day of May 1964 is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to divert the public right of way running from the south east corner of Bannisters Farm Playing Field in a north easterly direction to the railway line and thence across the railway line to Southway to a line running from the south east corner of the Playing Field along the perimeter thereof to a new footbridge across the railway line and thence to the southerly end of Greville Close.

## BRIXWORTH RURAL DISTRICT COUNCIL

*The Brixworth Rural (Moulton Public Path No. DD8) Extinguishment Order, 1964*

*Highways Act 1959**The Hale Urban District Council (Winchester Road) Public Footpath Extinguishment Order, 1964*

*The Borough of Darwen (Cranberry Lane) Public Path Creation Order 1963*

## DARWEN BOROUGH COUNCIL

*The Borough of Darwen (Cranberry Lane) Public Path Extinguishment Order 1963*
