

along this road to the junction with the A14 road in Royston, thence southwards along this road to its junction with the B1039 road, and thence south-eastwards along this latter road to the point TL 400390 (near Barley).

#### *Eastern Boundary*

From the point TL 400390 the boundary follows the B1368 road southwards through Barkway and Hare Street to its junction with the A10 road near Puckeridge, thence along this road to its junction with the A120 road and thence eastwards along this latter road to the point TL 484213 (in Bishops Stortford).

#### *South-Eastern Boundary*

From the point TL 484213 the boundary follows the A119 road south-westwards to the point TL 440193 (thence along the road via points TL 426185 and TL 426181 to the point TL 423180 (near Hadham Station) thence south westwards along the railway through Ware to Bayford Station, thence continuing in the same direction along the road past Woodfield to its junction with the A1000 road at point TL 259043, thence southwards along this road to the point TL 262031, and thence westwards along the road to the point TL 241031 (near Hawkshead Bridge).

#### *Western Boundary*

From the point TL 241031 the boundary follows the railway northwards through Hatfield and Welwyn Garden City to the point TL 240227 thence along the lane to the point TL 240228, and thence along the A1 road to the point TL 232254 (near Stevenage).

*An area of approximately 190 square miles in the Counties of Bedford, Hertford and Middlesex*

#### *North Western Boundary*

From the point SP 995076 (near Berkhamstead) the boundary follows the road north-eastwards past Great Gaddesden and Beechwood House to the crossroads in Markyate, thence north-westwards along the A5 road to its junction with the B4540 road, thence north-eastwards along this road to the point TL 071178, thence along the road past Woodside Farm to its junction once more with the B4540 road, thence continuing along this road to the junction with the A505 road in Luton. From this point the boundary follows the A505 road to the point TL 181290 (in Hitchin).

#### *Eastern Boundary*

From the point TL 181290 the boundary follows the A602 road south-eastwards to the junction with the A1 road near Stevenage, thence along this latter road to the point TL 240228 and along the lane to the point TL 240227. From this point the boundary follows the railway in a southerly direction through Knebworth and Welwyn Garden City to the point TL 241031 (near Hawkshead Bridge).

#### *Southern Boundary*

From the point TL 241031 the boundary follows the road westwards to its junction with the A1 road, thence southwards along this road to the point TL 228006 (near South Mimms), thence westwards along the road past Shenley to its junction with the A5 road near Radlett, thence southwards along this road to the point TQ 166991, thence south-westwards along the road past Letchmore Heath, Patchetts Green and Grove Place to its junction with the A411 road in Watford and westwards along this latter road to the point TQ 119954, thence north-westwards along the railway through Watford to the point TL 041059 to the west of Hemel Hempstead thence along the A41 road to the point SP 995076 (near Berkhamstead).

*An area of approximately 192 square miles in the Counties of Bedford, Buckingham and Hertford*

#### *North Eastern Boundary*

From the point TL 007405 (near Millbrook Station) the boundary follows the road south-westwards past Millbrook to the junction with the A418 road, thence eastwards along this road to the point TL 020382, thence south-eastwards along the railway to the point TL 095215 (in Luton).

#### *South Eastern and Southern Boundary*

From the point TL 095215 the boundary follows the A505 road to the point TL 093211, thence south-westwards along the B4540 road to the point TL 078195 and thence along the road past Woodside

Farm to the junction with the B4550 road, and thence in the same direction once more along this latter road to its junction with the A5 road and south-eastwards to the crossroads in Markyate. From this point the boundary follows the road south-eastwards past Beechwood House, through Great Gaddesden and Nettleden to the junction with the A41 road, thence north-westwards along this road to Northchurch Hall, thence westwards along the road past Cholesbury to the junction with the B4010 road in Wendover, thence along this road to its junction with the A4010 road and thence northwards along this latter road to the point SP 823070 (in Little Kimble).

#### *Western and North Western Boundaries*

From the point SP 823070 the boundary follows the railway northwards to the station in Aylesbury, thence north-eastwards along the road via the point SP 820136 to the junction with the A418 road thence along this road to the point SP 845159, thence via the point SP 842167 to the junction once more with the A418 road, and continuing north-eastwards along this road through Wing and Leighton Buzzard to the junction with the A50 road in Woburn, thence north-westwards along this latter road to the station in Woburn Sands. Then the boundary follows the railway north-eastwards to the point TL 007405 (near Millbrook Station).

*An area of approximately 196 square miles in the Counties of Cambridge, Bedford and Hertford*

#### *North Western Boundary*

From the point TL 020382 (near Ampthill) the boundary follows the A418 road eastwards to the crossroads at Ampthill, thence eastwards and north-eastwards along the A507 road to the junction with the A600 road in Shefford, thence northwards along this latter road to the point TL 143393 (near North Bridge). From this point the boundary continues along the course of the River Ivel Navigation to the point TL 188444 (in Biggleswade), thence eastwards along the road through Biggleswade via the point TL 189444 and TL 18445 to the point TL 197446, thence north-eastwards along the B1040 road through Potton and Gamlingay to the junction with the A45 road in Eltisbury, thence along this latter road to the point TL 296606 (near Caxton).

#### *North Eastern Boundary*

From the point TL 296606 the boundary follows the A14 road south-eastwards to the point TL 355407 (in Royston).

#### *South Eastern Boundary*

From the point TL 355407 the boundary follows the A505 road south-westwards to the junction with the A1 road in Baldock, thence continuing in the same direction along this latter road to the junction with the A602 road near Stevenage, thence north-westwards along this road to the junction with the A505 road in Hitchin, thence south-west along this latter road to the point TL 095215 (in Luton).

#### *South Western Boundary*

From the point TL 095215 the boundary follows the railway north-westwards to the point TL 021382 (near Ampthill).
