MINISTRY OF POWER

PETROLEUM (PRODUCTION) ACT, 1934

In pursuance of Section 2 (3) of the Petroleum (Production) Act, 1934, the Minister of Power hereby gives notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, as amended, he has granted to Superior Oil (U.K.) Limited, Chestergate House, Vauxhall Bridge Road, London S.W.1, four prospecting licences of which details of the boundaries, described from 2½ ins. Ordnance Survey maps are given in the Schedule below.

Maps showing the boundaries of the areas may be inspected on application to the Ministry of Power, Petroleum Division, Thames House South, Millbank, London S.W.1.

SCHEDULE

An area of approximately 9 square miles

All that part of the bed of the River Humber in the County of Lincoln which is bounded to the west by a straight line drawn from the point TA253119 (near Pyewipe Farm) to the point TA272140, to the north by the County Boundary to the point TA320131, to the east by a straight line drawn from the point TA320131 to the point TA320075 (near Cleethorpes), to the south by the High Water Mark of Ordinary Tides to the point TA298100, thence around Grimsby Docks via the points TA297100, TA293103, TA285106, TA284106, TA283107, TA283110, TA281111, TA280112, TA281114, TA280115, TA280116, TA278116 to the point TA273106 (near Lock Hill) thence by the High Water Mark of Ordinary Tides to the point TA253119, all the said points being located by reference to the National Grid.

An area of approximately 11 square miles

All that part of the bed of the River Humber in the Counties of Lincoln and York which is bounded to the west by a straight line drawn from the point TA077243 (near New Holland) to the point TA070266 (near Kingston Dock Extension), to the north by the High Water Mark of Ordinary Tides along the Northern Bank of the River Humber, thence via the points TA096279, TA096280, TA099281 and TA099280 to the point TA101281 (near Victoria Pier) thence by the Northern Bank of the River Humber to the point TA146282, thence via the point TA148285 to the point TA153286 and thence by the High Water Mark of Ordinary Tides to the point TA160274, to the east by a straight line drawn from the point TA160274 along Salt End Jetty and produced to the point TA148263, thence along the County Boundary to the point TA158244, thence by a straight line to the point TA151224 (near Halton Marshes), to the south by the High Water Mark of Ordinary Tides along the South Bank of the River Humber to the point TA077243, all the said points being located by reference to the National Grid.

An area of approximately 10 square miles

All that part of the bed of the River Humber in the Counties of Lincoln and York which is bounded to the west by a straight line drawn from the point SE936231 (near Winteringham Haven) to the point SE941257 (near Elloughton), to the north by the High Water Mark of Ordinary Tides along the North Bank of the River Humber to the point TA017255 (to the west of Hessele) to the east by a straight line drawn from the point TA017255 to the point TA107234 (to the west of Barton-upon-Humber), to the south by the High Water Mark of Ordinary Tides along the South Bank of the River Humber to the point SE936231, all the said points being located by reference to the National Grid.

An area of approximately 28 square miles

All that part of the foreshore in the County of Durham and of the seabed adjacent thereto which is bounded to the north west by a straight line drawn from the point NZ501360 (near Hart Warren) through the point NZ530390 to the limits of British territorial waters, to the north east and east by the limits of British territorial waters, to the south east by a straight line drawn from the point NZ558284 (in Tees Bay) through the point NZ580320 to the limits of British territorial waters, to the west by the Low Water Mark of Ordinary Tides from the point NZ501360 to the point NZ505357, thence by
