Traffic Regulation Order, 1964*

#### BIRMINGHAM CITY COUNCIL

*The City of Birmingham (Traffic Regulation)  
(No. 8) Order, 1964*

Notice is hereby given that the Lord Mayor, Aldermen and Citizens of the City of Birmingham acting by the Council have applied to the Minister of Transport for confirmation of an Order made by them under section 26 of the Road Traffic Act, 1960, the effect of which will be to prevent vehicular

access from the undermentioned street to the gyratory island at Six Ways, Aston, and into Lozells Road:

*William Street*: That part which lies north of a line drawn diagonally across William Street, so that at the western kerb it is 320 feet north of the kerb line on the north side of Gower Street and at the eastern kerb it is 300 feet north of the said Gower Street kerb line, and which lies south of a similar line drawn across William Street so that at the western kerb it is 342 feet north of the said Gower Street kerb line and at the eastern kerb it is 325 feet north of the said Gower Street kerb line.

###### *City of Coventry Development Plan*
