The Urban District of Camborne-Redruth (Fore Street, Camborne) (Prohibition of Waiting) Order, 1964.

Notice is hereby given that on the 29th June 1964, the Camborne-Redruth Urban District Council made an Order under the Road Traffic Act, 1960, the effect of which is that no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait in the length of road specified in the First Schedule hereunder or to wait between the hours of 9 a.m. and 6 p.m. on Monday to Saturday inclusive, in each week, during the period 1st June to the 30th September inclusive, in each year, in the length of road specified in the Second Schedule hereunder.

The Order will come into operation on the 1st August 1964, but exceptions are provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, or the maintenance, improvement, or reconstruction of any of the lengths of road or the services therein; to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said lengths of road; to enable the vehicle to be used in connection with a funeral.

FIRST SCHEDULE

Length of road in the Urban District of Camborne-Redruth.

Fore Street, Camborne (Class III Road) from the junction with Commercial Street, to the opening by No. 9 Fore Street, Camborne, such distance being 250 feet of thereabouts.

SECOND SCHEDULE

Length of road in the Urban District of Camborne-Redruth.

Fore Street, Camborne (Class III Road) from the opening by No. 9 Fore Street, Camborne, to its junction with Vyvyan Street, such distance being 150 feet or thereabouts.
