HONOURS AND AWARDS

CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD

St. James's Palace, London S.W.1.

7th August 1964.

The Queen has been graciously pleased on the advice of Her Majesty's Australian Ministers, to give orders for the undermentioned award of the British Empire Medal.

Awarded the British Empire Medal for Gallantry, (Civil Division):

John Baden WILLIAMS, Guide, Alice Springs.

An elderly man climbed to the top of Ayers Rock at Alice Springs but on the way down he slipped and fell to a ledge 600 feet above ground where he was unable to ascend or descend. Williams and another man climbed to a spot about 150 feet above the ledge. Williams climbed down to within about 30 feet of the trapped man and managed to throw him a rope. Williams then gradually pulled the man to safety. Williams completely disregarded the danger to himself while effecting the rescue. He had attached one end of the rope to his arm and the slightest slip would have plunged both men over the edge to their death.

This day the Lords being met a message was sent to the Honourable House of Commons, by the Gentleman Usher of the Black Rod, acquainting them that The Lords authorised by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to the Acts agreed upon by both Houses, to desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read, and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to:
