

At the Court at Buckingham Palace, the 27th day of July, 1964

PRESENT,

The QUEEN'S Most Excellent Majesty in Council

Whereas by the Burial Act, 1855 (18 & 19 Vict. c. 128.), it was, amongst other things, enacted that it should be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, should or should not have arrived), as to Her Majesty, with such advice as aforesaid, might seem fit:

And whereas an Order in Council was made on the 1st day of May, 1855 (hereinafter referred to as "the principal Order") directing the discontinuance of burials, in, amongst other places, the Churchyard of St. Michael, in the City of Coventry (now known as "the Old Graveyard"):

And whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the principal Order in so far as it affects burials in the said Churchyard should be varied:

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered as follows:—

1. The principal Order shall have effect subject to the following exception or qualification, viz.:—

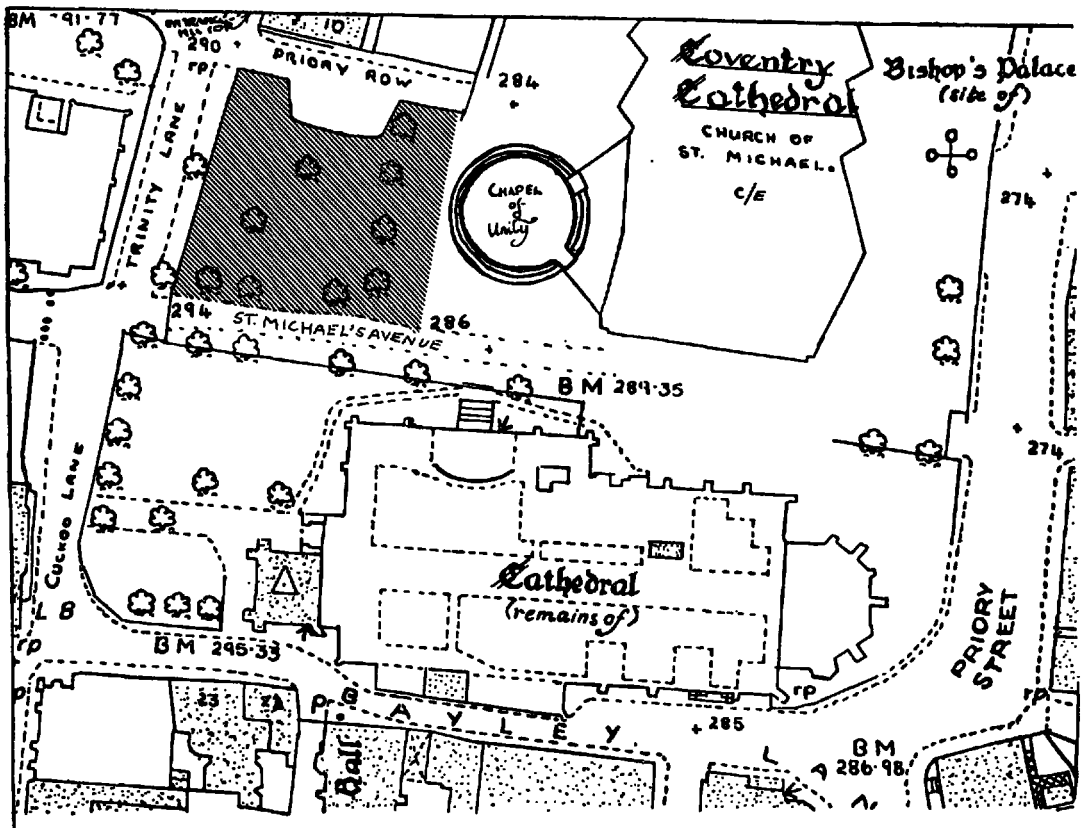
That, notwithstanding anything in the said Order in Council of the 1st day of May, 1855, the burial may be allowed, at their decease, of the bodies of Bishops and Provosts of the Cathedral Church of St. Michael, Coventry, and of their respective wives in that part of the said Churchyard which is bounded on the north by Priory Row, on the west by Trinity Lane, on the south by the causeway now or formerly known as St. Michael's Avenue and on the east by a strip of land contiguous with the Chapel of Unity (which area is shown hatched on the plan annexed hereto).

2. The Interpretation Act, 1889 (52 & 53 Vict. c. 63), shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. This Order may be cited as the Burial Grounds (Coventry) (Variation) Order, 1964.
