The Samford Rural District Council (Stratford St. Mary Paths Nos. 7 and 8) Diversion Order 1964

Notice is hereby given that on the 11th day of September 1964, the Minister of Housing and Local Government confirmed with modifications the above

Its effect is to divert the public rights of way described in "A" of the Schedule below to the routes described in "B" of the said Schedule. The old public rights of way will be closed as from the 2nd day of October 1964.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the offices of the Samford Rural District Council, 25, London Road, Ipswich, and at the Post Office, Stratford St. Mary, during normal office hours.

The Order becomes operative as from the 25th day The Order becomes operative as from the 25th day of September 1964, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.

Description of sites of parts of existing footpaths Section of Footpath No. 7

That part of footpath No. 7 of no recognisable width over its whole length of approximately 1,180 yards commencing at the northern corner of O.S. Field No. 12 at the point marked "A" on the said map being approximately 166 yards from the commencement of the said footpath at its junction with the road B.1068 and extending in a southerly direction for a distance of approximately 510 yards extending the said to the said footpath at the said footpath the road B.1068 and extending in a southerly direction for a distance of approximately 510 yards across O.S. Description of sites of new footpaths Section to form part of Footpath No. 7

A footpath of 4 feet in width over its whole length of approximately 1,460 yards commencing at the junction of existing footpath No. 7 with the northern corner of O.S. Field No. 12 at the point marked "A" on the said map being approximately 166 yards from the commencement of the said footpath at its junction with the road B.1068 and extending in a south-westerly direction for a distance of approximately 160 yards along the northern side of the north-western boundary of O.S. Field No. 12 to the junction of the said field boundary with footpath No. 8 at the point marked "C" on the said map and thence extending in a south-easterly direction along the existing route of footpath No. 8 for a distance of approximately 150 yards to the point marked "D" on the said map and thence extending in a south-

westerly direction for a distance of approximately 580 yards along the south-eastern boundary of O.S.
