PETROLEUM (PRODUCTION) ACT, 1934

In pursuance of section 2 (3) of the Petroleum (Production) Act, 1934, the Minister of Power hereby gives notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, as amended, he has granted to BP Petroleum Development Limited, Britannic House, Finsbury Circus, London E.C.2, two prospecting licences, of which details of the boundaries, described from the 2½" Ordnance Survey maps, and with reference to the National Grid, are given in the Schedule below.

SCHEDULE

An area of approximately 42 square miles in the County of Hampshire

Northern Boundary

From the point SZ 292849 (near the Needles Coastguard Station) the boundary follows the Low Water Mark of Medium Tides around Alum Bay to the point SZ 305856 (near Alum Bay Chine), thence eastwards via the point SZ 306856 to the point SZ 308855. The boundary then follows the road eastwards past Nodwell, and Middleton, to Black-

bridge Farm, thence in the same direction along the B.3399 road to the junction with the B.3401 road near Shalcombe, thence eastwards along this latter road past Calbourne, through Carisbrooke to the junction with the A.3020 road to the east of Shide.

Eastern Boundary

From Shide the boundary follows the A.3020 road southwards past Blackwater to Rookley, thence it continues southwards past Rookleygreen, Leechmore Farm, through Niton to the point SZ 502759 and thence via the points SZ 503757, SZ 502757, SZ 502756, SZ 501756 and SZ 504754 (on the Low Water Mark of Medium Tides near Reith Bay).

South Western Boundary

From the point SZ 505754 the boundary follows the Low Water Mark of Medium Tides northwards to the point SZ 292849 (near the Needles Coastguard Station).

An area of approximately 37 square miles in the County of Hampshire

Northern Boundary

From the junction between the B.3401 and A.3020 roads to the east of Shide, the boundary follows the road eastwards past Gallows Hill, Mersley Down and through Yarbridge and via the point SZ 624864 to the point SZ 633860 (near Glover's Farm) and thence by a straight line to the point SZ 640860 (on the Low Water Mark of Medium Tides in Whitecliff Bay).

South Eastern Boundary

From the point SZ 640860 the boundary follows the Low Water Mark of Medium Tides to the point SZ 505754 (in Reith Bay).

Western Boundary

From the point SZ 505754 the boundary follows a straight line to the point SZ 504754, thence in a northerly direction via the points SZ 501756, SZ 502756, SZ 502757, SZ503757 to the point SZ 502759, thence northwards along the road through Niton, past Leechmoor Farm, and Rookleygreen to Rookley, thence along the A.3020 road past Blackwater to the road junction to the east of Shide.

These areas were previously included in the area described in the *London Gazette* issue dated 24th July 1959.
