The QUEEN'S Most Excellent Majesty in Council

Whereas the Minister of Housing and Local Govern-Whereas the Minister of Housing and Local Government, after giving to the Incumbent and Churchwardens of the Parish of Bodicote, Banbury, in the County of Oxford, ten days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to Her Majesty in Council that, for the protection of the Public Health, burials should be discontinued forthwith and entirely in Bodicote Churchyard in the said Parish: Provided that-

(a) In any vault or walled grave now existing in the said Churchyard, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

(b) In any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, Her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 16th day

SCHEDULE

Special Service Pay (Flying)

Royal Marine Officers-Unit Light Aircraft

Helicopter Pilots

The conditions of issue of Special Service Pay (Flying) for Royal Marine Unit Light Aircraft Helicopter Pilots shall be as set out in the Order in Council of 3rd August 1960, Schedule IV paragraphs 1-4. Payment of Special Service Pay (Flying) shall not be made, however, save in the special circumstances allowed for in the above mentioned paragraphs,
