## Queen's Commendation for Brave Conduct

23845703 Lance Corporal (Acting Corporal) Gordon MUIR, 1st Battalion, The Royal Ulster Rifles.

When a fire occurred in an ammunition bunker Lance Corporal Muir, without order, and with com-plete disregard for his safety, went into the ammunition bunker and emerged carrying a box of phos-phorous grenades, which was burning violently. Having put down the box, he coolly went back into the ammunition bunker, and rescued Riffeman Neill. Just as they emerged, a phosphorous grenade blew up.

Lance Corporal Muir's coolness, courage and con-tempt of danger were of the highest order. His action not only saved the life of a brother Rifleman, but undoubtedly averted further casualties.
