

And whereas the said Francis Richard Kitchin has been convicted of offences against the Dangerous Drugs Act 1951 and cannot in my opinion properly be allowed to remain a person authorised as aforesaid:

Now, therefore, in pursuance of the power conferred on me by Regulation 22 of the said Regulations, I hereby withdraw from the said Francis Richard Kitchin the authorities aforesaid under the said Regulations 4 and 10:

And, in pursuance of Regulation 11 of the said Regulations, I hereby direct that it shall not be lawful for the said Francis Richard Kitchin to give prescriptions prescribing any substance for the time being falling within Part I of Schedule 1 to the Dangerous Drugs Act, 1964.
