EXTINGUISHMENT ORDER

The City and County of Bristol (Derham Road, Withywood) Public Path Extinguishment Order 1964.

Notice is hereby given that on the 15th day of March 1965, the Minister of Housing and Local Government confirmed, with modifications, the above Order.

Its effect is to extinguish the public right of way running from a point between Nos. 63 and 65 Derham Road, Withywood, and extending in a south-westerly direction across the allotments to Grange Road between Nos. 45-47.
