And Whereas Her Majesty is satisfied that the Government of the Republic of Cyprus has acceded to the Load Line Convention:

Now, therefore, Her Majesty, in pursuance of the powers vested in Her by the aforesaid section and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and doth hereby order, as follows:

1. It is hereby declared that the Government of the Republic of Cyprus has acceded to the Load Line Convention.

2. This Order may be cited as the Merchant Shipping (Load Line Convention) (Cyprus) Order 1965 and shall come into operation upon the date of its publication in the *London Gazette*.

## TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 7th May 1965, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £160,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday the 10th May 1965, to Saturday the 15th May 1965, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for.
