Summer, have suffered very much by Desertion, Sickness and Farigue; and have extreamly burden'd those Parts of the Kingdom through which they passed, that have been obliged to furnish them with Carriages, Provisions, and other Necessaries. whole Country of Provence is disabled from sur-nishing any surther Sums of Money towards the War, and hath therefore an Exemption from all kinds of Impolitions for some Years, which his Majesty hath thought very reasonable, notwithstanding the extraordinary Expence he hath been at for the Defence of Toulon, and what will be necessary for repairing of the Losses he hath sustained there. The Duke de la Tremoille is appointed to go into Spain, with his Majesty's Compliments on the Birth of the Prince of Asturia. We hear the Spaniards are very much discontented at the Loss of the King-dom of Naples, which the Court excuses by reason of the Enemy's Fleet lying before Toulon, and pre-venting the Transportation of Troops that were defigned for the Defence of that Kingdom.

From the Camp at Helchin, Sept. 12. The Enemy, upon our coming to this Camp, have put a Reinforcement of several Squadrons and Battalions into Tourney; and this Day's Detachment of 800 Men, with 1000 Workmen, were ordered out to make Ways forward from our Camp towards the Plains of Calandre, which they have perfected, for the March of 8 Columns, without any Opposition from the Enemy.

Hague, Sept. 13. N.S. Letters from France speak of an Engagement between two Detachments of the Armies in Catalonia, in which they pretend the French Armies in Catalonia, in which they pretend the French had the Advantage, though by private Letters we are informed they were forced to retire, the Loss being near equal on both Sides. We have Advice, That the Squadron under the Command of the Chevalier de Fourbin have taken or burnt 18 of our Fleet of Merchant-ships that were bound for Archangel. They write from Francfort, That the Elector of Hanover arrived on the 6th Instant at Volbel, near that Place, and that his Electoral Highness dined the next Day at Hochst with the Elector of Mayence. Several Regi-Hochst with the Elector of Mayence. Several Regiments of Lunenburg and Prussia were passed by that Place on the same Day, in order to join the Imperial Army, which was still encamped at Etlingen. The Margrave of Bareith religned his Command on the 3d Instant, and was retired with the Prince Heredirary his Son, having left Count Gronsfelt at the Head of those Forces, General Thungen being at Philipsburg.

The French continue in their Camp of Rastad, and are casting up very strong Intrenchments.
