The QUEEN has been graciously pleased, on the recommendation of the President of the Board of Trade, to award the Bronze Medal for Gallantry for Saving Life at Sea to Mr. George Alfred Tomlinson, s.s. "San Fabian".

At about 15.00 hours on the 14th August, 1964, the s.s. "San Fabian" about five miles off Gibraltar on voyage from Venezuela to Italy, lurched in a rough sea and an eighteen year old junior seaman, Malcolm Mahoney, who was painting a gangway davit, slipped and fell into the sea.

Deck hand George A. Tomlinson who was working nearby, saw the fall and after raising the alarm dived overboard to help Mahoney whom he knew to be a poor swimmer. Mr. Tomlinson showed him how to "dog paddle" and encouraged him to keep afloat for over one hour. Meanwhile the "San Fabian" had swung around and was searching for the two men. At 15.51 hours both men were sighted and a lifeboat was lowered and sent to the rescue. They were picked up at 16.15 hours and taken to the ship's hospital suffering from shock and exposure. Both men recovered after treatment.

There is no doubt that Mr. Tomlinson's prompt and courageous action, at great risk to himself, saved Mr. Mahoney's life.
