The Secretary of State for the Home Department hereby gives notice that on the 5th day of May 1965, a representation was duly made to him by the City and County Borough Council of Sheffield that the Fairs which have been held from time to time on land formerly known as the Smithfield Market, Blonk Street, Sheffield, and on the streets adjoining such land have not been held for twenty-five years and that it would be for the convenience and advantage of the public that such Fairs should be abolished. On the 10th day of June 1965, the Secretary of State will take such representation into consideration, and any person who may desire to object to the abolition of the Fairs should indicate his objections to the Secretary of State before that day.
