Notice is hereby given that by an Order made on Wednesday the 5th day of May 1965 upon the Petition of the above named Maison Mason Limited and of Winifred Kathleen Mason on the 5th day of May 1965 preferred unto this Court and upon hearing the Solicitor for the Petitioners and the Solicitor for the Registrar of Companies, the Respondent to the said Petition and upon reading the said Petition the Affidavit of the said Winifred Kathleen Mason filed on the 9th day of March 1965 and the Affidavit of John Gordon Smith filed on the 5th day of May 1965 and the exhibits in the said Affidavits respectively referred to and there being no opposition on behalf of the Solicitor for the Affairs of the Duchy of Lancaster to the relief sought by the said Petition as appears from the said Affidavit of John Gordon Smith and in the exhibit thereto and the Petitioners by their said Solicitor jointly and severally undertaking forthwith:—

1. To take all steps necessary for procuring that the said Company be put into voluntary liquidation immediately following the restoration of its name to the Register.

2. To make up and forward to the Registrar of Companies the annual return of the Company for the year 1964 as required by sections 124 and 126 of the Companies Act 1948.

3. To give to the Registrar of Companies a Notice of Change in the situation of the Company's Registered Office (if such be the case) as required by section 107 of the said Act.

4. To send to the Registrar of Companies a Notification of Changes among the Company's Directors or in its Secretary or in their particulars as required by section 200 of the said Act.

The Court Ordered that the name of Maison Mason Limited be restored to the Register of Companies.

And it was Ordered that an office copy of this Order be delivered to the Registrar of Companies and pursuant to the said Act the said Maison Mason Limited is thereupon deemed to have continued in existence as if its name had not been struck off.

And it was Ordered that the Registrar of Companies do advertise this Order in his official name in the *London Gazette*.

And it was Ordered that the Petitioners the said Maison Mason Limited and Winifred Kathleen Mason do jointly and severally pay to the Registrar of Companies all his costs of the said Petition such costs to be taxed if necessary on the High Court Scale.

PETROLEUM (PRODUCTION) ACT, 1934

In pursuance of Section 2(3) of the Petroleum (Production) Act, 1934, the Minister of Power hereby gives notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, as amended, he has granted a prospecting licence to BP Petroleum Development Limited, Britannic House, Finsbury Circus, London E.C.2 in respect of 152 square miles in the counties of Nottingham, Leicester and Rutland.
