THE TRUNK ROAD (BRIDGE STREET, CASTLE SQUARE AND POOL STREET, CAERNARVON) (PROHIBITION OF WAITING) ORDER.

The Secretary of State proposes to make an Order under sections 26 and 28 of the Road Traffic Act 1960, the effect of which will be that:

(a) The Borough of Caernarvon (Traffic Regulation—Pool Street) Order, 1948 and the Borough of Caernarvon (Traffic Regulation) Order, 1954, which relates to Bridge Street will be revoked and

(b) No person shall cause or permit any vehicle to wait in that length of the Fishguard—Bangor Trunk Road (A.499) known as Bridge Street, Castle Square (the north side), and Pool Street in the Borough of Caernarvon which lies between its junction with Turf Square and its junction with Snowdon Street.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

An exception will also be provided to enable goods to be loaded on to or unloaded from the vehicle, provided that no vehicle (other than a vehicle being used for the purpose of delivering or collecting postal packets for the Post Office) shall wait, on any day between 10.30 a.m. and 6 p.m. during the period 1st July to 15th September each year.

THE TRUNK ROAD (THE ROE, ST. ASAPH) (PROHIBITION OF WAITING) ORDER 1965
