(b) Notices under the Companies Act, 1948:

(i) Notice of Appointment of Liquidator pursuant to Section 305 of the Act and the Companies (Forms) Order, 1949 (S.I. 1949 No. 382): 10s. 0d.

(ii) Notice of Advertisement of Petition pursuant to Rule 28 of the Companies (Winding-up) Rules, 1949 (S.I. 1949 No. 330): 10s. 0d.

(iii) Notice pursuant to the Companies (Posed of Tardy) For Order 1962 (S.Y. 1962 No. 1963)
