Notice is hereby given that the Kent County Council have applied to the Minister of Transport for confirmation of the Orders made by them under sections 26 and 27 of the Road Traffic Act, 1960, which are specified in the Schedules hereto. Their effect will be as indicated in the respective Schedules and it should be noted that, in the cases of roads specified in the First Schedule having serial numbers with the prefix "W", the existing restrictions are to be replaced by restrictions on the widths of vehicles permitted to use those roads as indicated in the Second Schedule.

FIRST SCHEDULE

The County Council of Kent (Various Roads) (Restrictions on Driving) (Revocation) Order, 1965

This Order will remove the restrictions imposed by the County of Kent Roads (Restriction) Orders, 1926 and 1931 (as amended) on the use of the following lengths of road by vehicles of specified classes or by vehicles which exceed specified weights:

<i>Borough or District</i>	<i>Serial No.</i>	<i>Length of Road</i>
Bridge-Blean Rural	W.4	Out-Elmsted Lane, Barham, from the Canterbury-Dover road to its junction with the Barham-Kingston road.
Bridge-Blean Rural	W.5	The road from Shalmsford Street-Lower Hardres road at County Asylum via Garlinge Green to its junction with the Canterbury-Waltham road at Petham.
Bridge-Blean Rural	17	The road (a) from the road junction about 170 yards south-west of the School, Hoath, via Chislet Forstal to the road junction near the Vicarage, Hollow Street, including the branches (b) from a point 400 yards east of the road junction at Old Tree to the road junction at the Six Bells Inn, Chislet; and (c) from the road junction at Bristles Corner to the road junction about 100 yards south of the Smithy Millbank.
Bridge-Blean Rural	18	The road from the Canterbury-Faversham road at Upper Harbledown via Howfield Wood and Chartham Hatch to its junction with the Chilham-Canterbury road at Chartham.
Bridge-Blean Rural	19	The road from the Canterbury-Dover road at Bishopsbourne to its junction with the cross roads north of Coldharbour Farm, Bishopsbourne.
Bridge-Blean Rural	20	(a) The Canterbury-Stodmarsh road from the Canterbury-Sandwich road via Swanton Farm to its junction with the Wickhambreaux-Grove-Sarre road south of Grove Hill, including (b) the branch to St. Mary's Church, Stodmarsh.
Bridge-Blean Rural and Elham Rural ...	21	The road from the Bridge-Street End road east of the railway bridge via Pett Bottom, Lynsore Bottom and Fryarne Park Road to its junction with the fork roads leading to the Sellindge-Stelling Minnis-Lyminge road.
Broadstairs and St. Peters Urban ...	W.1	Whiteness Road and Kingsgate Bay Road.
Cranbrook Rural	W.6	The road from the Cranbrook-Hawkhurst road near Yew Tree Farm via Primrose Hill to its junction near Pix Hall, High Street, with the Ticehurst-Sandhurst road.
Cranbrook Rural	W.7	The road from Biddenden Road at East End via Stepneyford Bridge to its junction near Beacon Hill with the Cranbrook-Rolvenden Road.
Cranbrook Rural	W.8	The road from the Iden Green-Sandhurst road at Spunden to its junction at Beeches Farm, Field Green, with the Ticehurst-Sandhurst road.
Cranbrook Rural	22	Water Lane from the Cranbrook-Hawkhurst road at Tubslake to its junction with Potter's Lane, Four Wents, and from that junction to its junction at Pipsden with the Ticehurst-Sandhurst road.
Cranbrook Rural	23	Walkhurst Road from Biddenden Road at Goddard's Green to its junction at Benenden with the Cranbrook-Rolvenden road.
Cranbrook Rural and Tenterden Rural ...	W.9	The road from the East End-Stepneyford Bridge road near Backtilt Wood via Mount Pleasant and Halden Place to its junction near Rolvenden with the Rolvenden-Tenterden road.
Cranbrook Rural and Tenterden Rural ...	W.10	The road from the Sandhurst-Newenden road at the Manse via Hoad's Farm, Hope House, Dingleton and Ramsden to its junction near Beacon Hill with the Cranbrook-Rolvenden road, including the branch via Devenden to the junction at West Cross with the Cranbrook-Rolvenden road.
Dartford Rural	W.13	(a) Pettings Road from the Ridley-Ash Road at Berry's Maple via Pettings and Gorse Farm to its junction with the Gravesend-Wrotham Road at the milestone, Gravesend, 8, including (b) the branch, Rosemary Lane, to its junction with the Ridle-South Street road.
Dartford Rural	W.14	Hartley's Bottom from its junction with the Ridley-Ash road at Berry's Maple to its junction with the entrance to the Longfield Refuse Depot at the south end of the railway bridge approach.
