CONFIRMATION OF PUBLIC PATH ORDER

*Hemel Hempstead (Gravel Hill Terrace)
Footpath Extinguishment Order 1965*

Notice is hereby given that on the 29th day of October 1965, the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to extinguish the public right of way running in a south-easterly direction along the northern side of Gravel Hill Terrace for a distance of 175 yards or thereabouts to its junction with Gravel Hill Terrace.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at The Town Hall, Marlowes, Hemel Hempstead, Herts, between 9 a.m. and 5 p.m. on any weekday.

The Order becomes operative as from the 19th day of November 1965, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.

Path Diversion Order, 1965*

Rural District of Forehoe and Henstead (Parish of Framingham Earl Footpaths Nos. 5 and 6) Footpath Extinguishment Order 1962.

Notice is hereby given that the above Order made on the 7th day of December 1962 is about to be submitted to the Minister of Housing and Local Government for confirmation.

The Order relates to land situate in the parish of Framingham Earl.

Its effect will be to extinguish the Public Rights of Way of an undefined width but not exceeding three feet, commencing in Long Lane and joining footpath No. 6. Footpath No. 6 commences on the Norwich/Bungay Road and traverses the northern side of the boundary of the parish of Poringland and emerges to the Ugate Road.
