Subject to the exemptions provided by virtue of section 11 (4) of the Act, if, on any day after the Orders have come into operation, smoke is emitted from a chimney of any building within the smoke control areas the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Orders will not come into operation before the 1st day of October 1966, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Orders and of the maps referred to therein may be inspected free of charge at the office of the Clerk of the Council, Town Hall, Baildon, at all reasonable times during the period of six weeks from the 16th day of November 1965.

Within the said period any person who will be affected by the Orders may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Orders.

## COAST PROTECTION ACT, 1949

#### VENTNOR URBAN DISTRICT COUNCIL

The Ventnor Urban District Council, acting in their capacity as coast protection authority, hereby give notice under sub-section (1) of section 5 of the above Act that they propose to carry out coast protection work as described herein between the eastern end of the Esplanade and the Cat Rock sewer outfall at Wheelers Bay, Ventnor.

The work will consist of the construction of new sea walls (with sloping concrete aprons) between—

- (a) the eastern end of the Esplanade and the western end of the old gasworks site, and
- (b) Wheelers Bay boathouse and Cat Rock sewer outfall.

A 12 feet wide access road will be constructed behind the new sea walls and also between Wheelers Bay boathouse and the eastern end of the old gasworks site. Around the latter site, toe protection to the existing wall will be given by timber pile breastwork with rocks packed behind.

The estimated cost of the works is £128,700.

Any person may, not later than 8th December 1965, serve a written notice of objection to the above proposal on the Minister of Housing and Local Government and on the above-mentioned authority. Any such notice must contain a statement of the grounds of objection and must be sent by pre-paid post to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, and to the Clerk of the authority at the address shown below.
