

That length of the Fishguard—Aberystwyth—Dolgelley—Caernarvon—Bangor (Menai Suspension Bridge) Trunk Road (A.487), known as Main Street in the Urban District of Fishguard and Goodwick in the County of Pembroke, which lies between The Square and a point 215 yards east of The Square.

#### SCHEDULE 2

The south-west side of that length of the London—Fishguard Trunk Road (A.40), known as West Street in the Urban District of Fishguard and Goodwick in the County of Pembroke, which lies between a point 140 yards north-west of The Square and a point 210 yards north-west of The Square.

#### WESTERN VALLEYS (MONMOUTHSHIRE) SEWERAGE BOARD

Whereas the Western Valleys (Monmouthshire) Sewerage Board (hereinafter referred to as "the Board") have applied to the Secretary of State for a Provisional Order under section 303 of the Public Health Act, 1875, partially to repeal alter and amend the Western Valleys (Monmouthshire) Sewerage Board Acts and Order, 1903-1931 (hereinafter referred to as "the said Acts and Order") for the following purposes:

1. To enable the Board to prohibit the making of connections to the trunk sewer by the Magor and St. Mellon's Rural District Council where in the opinion of the Board this would lead to surcharging of the sewer;

2. To enable the Board to establish a reserve fund;

3. To give the Board additional powers by making the following enactments applicable to the Board:

(a) Section 267 of the Local Government Act, 1933, so as to enable the Board to pay certain expenses incurred in connection with conferences;

(b) Section 306 of the Public Health Act, 1936, so as to make the purposes of the said Acts and Order purposes for which the Board may be authorised by the Secretary of State to purchase land compulsorily;

(c) Section 116 of the Local Government Act, 1948, so as to enable the Board to pay to the Chairman of the Board, for the purpose of enabling him to meet the expenses of his office, such allowance as the Board may think reasonable;

(d) Section 129 of the Local Government Act, 1948, so as to enable the Board to pay reasonable subscriptions to local government associations;

(e) Section 130 of the Local Government Act, 1948, so as to enable the Board to insure against accidents to members;

(f) Section 1 of the Local Authorities (Expenses) Act, 1956, so as to enable the Board to defray certain expenses in connection with official and courtesy visits;

4. To revise the said Acts and Order by repealing certain obsolete provisions and by making applicable to the Board certain enactments contained in the Local Government Act, 1933, the Public Health Act, 1936, and the Public Utilities Street Works Act, 1950, which are applicable to local authorities generally.

Notice is hereby given that the Secretary of State will consider any objections or representations made to him in writing before 31st December 1965, by any person or body interested in the subject matter of the application. #### THE TRUNK ROAD (NEWPORT, PEMBROKE) (PROHIBITION OF WAITING) ORDER 1965

Notice is hereby given that the Secretary of State has made an Order under section 26 of the Road Traffic Act 1960 the effect of which is to prohibit waiting in that length of the Fishguard—Aberystwyth—Dolgelley—Caernarvon—Bangor (Menai Suspension Bridge) Trunk Road (A.487) known as Lower West Street, Lower Bridge Street and East Street, at Newport in the county of Pembroke, which lies between its junction with Upper West Street and a point 50 yards east of its junction with St. Mary's Street.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, and also to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
