

are now order'd to discharge that Demand in Money; which will be of great Ease and Relief to the Peasants, and prove much more convenient for his Majesty's Purposes. His Majesty hath set aside the greatest part of this Week for taking a Review, and seeing the Troops exercise which are in this City. On the 22d Instant he reviewed the Grenadiers, who are very well Cloath'd, and perform'd their Exercises to his Majesty's Satisfaction. This Morning the Regiment of the Prince Royal, and a Battalion commanded by the Prince of Hesse, pass'd in Review before the King.

*Hague, November 11.* N. S. Count Wratlaw, who lately assisted in the Conferences at Francfort, resides here at present, and sollicitates in the Behalf of his Imperial Majesty a Loan of 600000 Crowns. There appears a greater Disposition towards closing with that Proposal than heretofore. The Duke of Wirtemberg offers some Revenues of his Dukedom as a Security for 200000 Crowns, which he also would borrow of this State. That Affair lies under present Consideration, and there is a great Inclination to comply with the Duke's Request. The greater Number of the General Officers is arriv'd here from the Army in Flanders. The Duke of Wirtemberg, who commands the Danish Auxiliary Troops, is preparing to go to the Court of Denmark. Don Bernardo de Quiros has open'd to the States his Commission of Plenipotentiary from his Catholick Majesty. That Minister will dispatch a Courier to his Master to Morrow, to carry the Resolutions which are taken concerning the Palatine and other Troops design'd for the Service in Catalonia. They write from Hamburgh, That General Patkull, late Minister of State, and Ambassador from his Czarish Majesty, was executed the 10th of last Month near the Convent of Casimir, between Posnanie and Slupenza, which at that time were the Head-Quarters of the Swedish Army. Letters from Dresden inform us, That the Roman-Catholicks of Silesia, and particularly the Jesuits, very much oppose the Restitution of the Churches and Estates which have been taken from the Protestants: Upon which his Imperial Majesty has sent fresh Orders to his Commissioners to repair immediately to Breslaw, and take effectual Measures for putting the Treaty with the King of Sweden in Execution.

*His Royal Highness Prince George of Denmark, Lord High Admiral of Great Britain, is pleased to direct, That all such Men as do belong to Her Majesty's Ship the Greyhound at Sheerness, which are in or about Town, do forthwith repair to their Duty on board the said Ship, she being order'd on immediate Service; otherwise they will be taken up and try'd as Deserters from Her Majesty's Service.*

*Whereas one William Sale was some Years since convicted in the Ecclesiastical Court at Canterbury, of having forged Holy Orders for himself, and for his own Father, under the Hand and Seal of the late Bishop Pearson of Chester; upon which he was deprived of the Living of Sturry, in the Diocese of Canterbury: And whereas a Person, of the same Name of William Sale, came lately to Eden-Bridge in the Diocese of Rochester, and there taught School, read public Prayers, and preach'd several times, without License from the Bishop; and having been often warn'd to come and exhibit his Letters of Orders to the Diocesan, or his Court, he never appear'd with them, but alleged, that they were registred in the Court of Canterbury, and in possession of the Arch-Deacon there. These are therefore to advise and require the same William Sale to appear before the Lord Arch-Bishop of Canterbury his Grace, or before the Bishop of Rochester, within the Space of one Month after the Date of these Presents; to produce his own Letters of Orders, if he has any; or else he shall be proceeded against further in the Bishop of Rochester's Court; and Notice shall be publicly given of him to all the Archbishops and*

*Bishops of England and Ireland, that he is justly supposed to be the foresaid William Sale, who was convicted at Canterbury for forging Orders, upon evident Proof, besides the Authentic Confession of his own Father.*
