The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under section 7 of the Finance (No. 2) Act 1964, viz.: Export Rebates (Rates of Rebate) Order 1965.

This Order prescribes a new schedule of rates of export rebate applicable to goods exported on or after 1st January 1966. It revokes the existing schedule of rates of rebate except as respects goods. export rebate applicable to goods exported on or after 1st January 1966. It revokes the existing schedule of rates of rebate except as respects goods exported before that date. Where appropriate the rates are increased to reflect the increases in vehicles excise duty effected by the Finance Act 1965, and other minor amendments are made. Goods to which the new schedule of rates is applicable are to be classified by reference to the Export List 1966.

The Order comes into operation on the 1st January 1966 and has been published as Statutory Instrument 1965 No. 2075.
