## LONDON BOROUGH OF HAVERING

Havering (No. 2) Smoke Control Order, 1965 Notice is hereby given that the Council of the London Borough of Havering in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956 on the 8th day of December 1965, made an Order entitled Havering (No. 2) Smoke Control Order, 1965, declaring the area described in the schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10, unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st November 1966, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order (and of the map referred to therein) may be inspected free of charge at the offices of the Borough Solicitor, Council Offices, Billet Lane, Hornchurch, at all reasonable times during the period of six weeks from the 17th December 1965.
