### NATIONAL COAL BOARD

THE OPENCAST COAL ACT, 1958

Notice is hereby given that the Minister of Power, in exercise of the power conferred upon him by section 1 of the Opencast Coal Act, 1958, granted on the 11th day of January 1966, to the National Coal Board an authorisation entitled the Mossey Green Authorisation, 1966, to work coal by opencast operations or cause or permit coal to be worked by opencast operations.

SCHEDULE

The land comprised in the application is located approximately two and a half miles south-east of Wellington in the County of Salop. It lies East of The Rock and is bounded on the West partly by Roc's Road and partly by Mannerley Lane and on the east by Clares Lane. It is included in Ordnance Survey Sheet S.J.6809, Edition 1956, Scale 1/2500. The area of the site is 32.96 acres.
