of England. 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount the bills required are to be dated, and the net amount

than £30,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates. 5. Tenders must be made through a London Banker, Discount House or Broker. 6.
