

Stanley Road (East Side)

From a point 130 feet south of the south kerb line of Merton Road to a point 45 feet north of the north kerb line of Trinity Road and from a point 45 feet south of the south kerb line of Trinity Road to a point 120 feet north of the north kerb line of Balliol Road.

Trinity Road (South Side)

From a point 45 feet east of the east kerb line of St. Alban's Square to a point 45 feet west of the west kerb line of Stanley Road.

Glover's Lane (South-west Side)

From a point 105 feet west of the west kerb line of St. Jerome's Way to a point 45 feet west of the west kerb line of St. Jerome's Way, and from a point 45 feet east of the east kerb line of St. Jerome's Way to a point 15 feet west of the west kerb line of the service road, and from a point 45 feet east of the east kerb line of the service road to a point 45 feet west of the splayed kerb line produced of Glover's Lane/St. Oswald's Lane roundabout junction.

Glover's Lane (North-east Side)

From a point 105 feet west of the west kerb line produced of St. Jerome's Way to a point 45 feet west of the west kerb line of Magdalene Square, and from a point 45 feet east of the east kerb line of Magdalene Square to a point 45 feet west of the splayed kerb line produced of Glover's Lane/St. Oswald's Lane roundabout junction.

(c) To prohibit the waiting of vehicles at all times on the following lengths of road:
