Imposition of 30 m.p.h. speed limit

Notice is hereby given that the Dorset County Council intend to apply to the Minister of Transport for her consent to the making, under the Road Traffic Act, 1960, of an Order the effect of which will be that the lengths of road specified in the Schedule to this notice shall become subject to a speed limit of 30 m.p.h.

Any objection to the making of the Order should be sent to the Clerk of the County Council, County Hall, Dorchester, not later than 31st March 1966.

SCHEDULE

Lengths of roads in the Rural District of Beaminster

1. *Beaminster*: That length of the Class III road leading from Beaminster to Stoke Abbott which extends from a point 53 yards south-west of its junction with Clay Lane to a point 278 yards south of that junction.
2. *Mosterton*: That length of the Beaminster-Mosterton road (A.3066) which extends from the north side of its junction with Potwell Lane northwards to its junction with Mosterton Down Lane.

Lengths of roads in the Rural District of Blandford

3. *Charlton Marshall*: That length of the Blandford-Poole road (A.350) which extends from a point 20 yards north of its junction with Gravel Lane to a point 80 yards north of that junction.
4. *Milborne St. Andrew*: That length of the Puddletown-Blandford road (A.354) which extends from its junction with the Dawlish Road eastwards to a point 420 yards east of that junction.

Length of roads in the Urban District of Sherborne

5. *Sherborne*: Horsecastles Lane and Ottery Lane (A.352) between its junction with the Sherborne-Yeovil road (A.30) and its junction with Westbury.

Length of road in the Borough of Wareham and the Rural District of Wareham and Purbeck

6. *Wareham and Wareham St. Martin*: That length of Carey Road in the Borough of Wareham and the Parish of Wareham St. Martin which extends from a point 30 yards east of its junction with the eastern side of Wessex Oval to a point 350 yards west of that junction.

Lengths of roads in the Rural District of Wareham and Purbeck

7. *Winfrith Newburgh*:
 - (i) That length of Class III road leading from Winfrith Newburgh to West Lulworth which extends from its junction with the Dorchester-Wareham road (A.352) to a point 300 yards south-east of its junction with the road leading to East Chaldon.
 - (ii) That length of road leading from Winfrith Newburgh to East Chaldon which extends from its junction with High Street, Winfrith Newburgh to a point 107 yards south-west of that junction.
8. *Wool, Bovington*: That length of Cologne Road, Bovington, in the Parish of Wool, which extends from its junction with Bovington Lane (C.115) to a point 85 yards north of its junction with the north-western side of Alamein Road.

Lengths of road in the Rural District of Wimborne and Cranborne

9. *Cranborne*:
 - (i) That length of Salisbury Street which extends from its junction with the western end of Griggs Lane to a point 185 yards north of that junction;
 - (ii) That length of the Wimborne-Damerham road (B.3078) which extends from a point 253 yards south of its junction with Castle Street to its junction with the eastern end of Griggs Lane;
 - (iii) That length of Castle Street which extends from its junction with Wimborne Street (B.3078) to a point 114 yards east of its junction with Castle Lane.

Imposition of 40 m.p.h. Speed Limit

Notice is hereby given that the Dorset County Council intend to apply to the Minister of Transport for her consent to the making of an Order under Section 11((1) of the Road Traffic Act, 1962, prohibiting the driving of motor-vehicles at a speed exceeding 40 m.p.h. on any of the lengths of roads specified in the Schedule to this Notice.

The following of these lengths of roads is at present subject to a speed limit of 30 m.p.h.:

Swanage, High Street (A.351) between a point 84 yards west of its junction with Victoria Avenue and its junction with Day's Road.

Lengths of road in the Urban District of Swanage

1. *Swanage*: That length of High Street (A.351) which extends westwards from a point 84 yards west of its junction with Victoria Avenue to the boundary of the Swanage Urban District.

Lengths of roads in the Rural District of Wareham and Purbeck

2. *Lytchett Matravers*: (i) That length of Wareham Road between its junction with Bulbury Lane and its junction with Huntick Road.
(ii) That length of Chapel Road between its junction with Huntick Road and a point 180 yards north of that junction.
3. *Lytchett Minster*: That length of Blandford Road, Upton (A.350) which extends from a point 120 yards north-west of its junction with Dorchester Road (A.35) to a point 390 yards north-west of that junction.

Lengths of roads in the Rural District of Wimborne and Cranborne

4. *Verwood*: That length of Newtown Road which extends southwards from its junction with Ringwood Road (B.3081) to its junction with Manor Road (B.3072).
5. *West Parley*: Pinehurst Road between its junction with Moorside Road and its junction with Ringwood Road (A.31).
