- 1. This Order may be cited as the Southern Rhodesia (Prohibited Exports) (Sugar) Order 1966 and shall come into operation on the 18th March 1966.
- Sugar is hereby specified for the purposes of Article 1(1) of the Southern Rhodesia (Pro-hibited Exports and Imports) Order 1966.
 In this Order "sugar" means sugar cane, sugar and sugar syrups (whether or not flavoured or coloured), molasses and caramel.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order specifies sugar for the purposes of Article 1 (1) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966. This has the result of prohibiting the exportation of sugar from Southern Rhodesia and certain ancillary transactions except so far as may be authorised by regulations of the Secretary of State.
