The QUEEN has been graciously pleased to give orders for the following appointment to the Most Excellent Order of the British Empire in recognition of gallant conduct in Aden.

To be an Additional Member of the Military Division of the said Most Excellent Order, for Gallantry:

Major John Howard Searles BURGESS (387679), The Queen's Royal Surrey Regiment.

Major Burgess has been employed as a Military Intelligence Officer working under Headquarters Aden Brigade. He first came to Aden in February 1965, for a six months emergency tour. After his return to England in August 1965, he voluntarily returned for a further emergency tour of three months.

After working initially as a desk officer, Major Burgess took part in many operations against terrorists. He has been personally connected with the capture of at least twenty-six terrorists who are now detained, and he has made many other arrests of persons required for questioning. These arrests, normally carried out at night, often against armed men, have involved considerable personal risk.

Major Burgess recently attempted to meet what was thought to be a friendly agent under cover of darkness. On arriving at the agreed meeting place he discovered that the agent was accompanied by several other persons who were probably armed, in what later proved to be a wanted car. On another occasion, completely disregarding his personal safety, and on his own initiative, he planned and led a small party of soldiers into a known terrorist area resulting in the capture of a quantity of terrorist arms and ammunition. The weapons recovered included a Sten gun taken from a British Serviceman on the previous day.

These are two examples of the degree of risk and danger to which this officer has been exposed.

Throughout his tour in Aden Major Burgess has repeatedly ignored risks to his own personal safety and has displayed a high degree of courage and devotion to duty far beyond the normal call.
