

LEIGH BOROUGH COUNCIL

The Borough of Leigh Smoke Control Order (No. 4) 1966

Notice is hereby given that the Mayor, Aldermen and Burgesses of the Borough of Leigh, acting by the Council of the said Borough, in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 6th day of May 1966, made an Order entitled the Borough of Leigh Smoke Control Order (No. 4) 1966, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st August 1967, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Hall, Leigh, at all reasonable times during the period of six weeks from the 20th day of May 1966.

Within the said period any person who will be affected by the Order may by notice in writing to The Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order,

SCHEDULE

An area containing in the whole 191 acres or thereabouts bounded on its several sides by the following and including:

(a) On the North Side by:

The Borough boundary at Lilford Park from its junction with the Leigh/Manchester railway line to its junction with The Avenue.

The East side of The Avenue to its junction with Leigh Road.

(b) On the West Side by:

The East side of Leigh Road from its junction with The Avenue to its junction with Church Street.

(c) On the South side by:

The North side of Church Street from Leigh Road to its junction with Brown Street South.

The East side of Brown Street North from its junction with Church Street to its junction with East Bond Street.

The North side of East Bond Street to its intersection with the Railway Line at Leigh Station.

(d) On the East side by:

The Railway Line from its junction with East Bond Street to the Borough boundary at Lilford Park.

The Cassiobury Smoke Control Order (No. 5) 1966

Notice is hereby given that the Watford Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 14th day of February 1966, made an Order entitled "The Cassiobury Smoke Control Order (No. 5) 1966", declaring the area described in the schedule hereto to be a smoke control area which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

If on any day after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st October 1967, or before a later date determined by the Minister of Housing and Local Government.

A copy of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Town Hall, Watford, at all reasonable time during the period of six weeks from the 27th day of May 1966.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

SCHEDULE

The Cassiobury Smoke Control Order (No. 5) 1966

The area is bounded on the northern and eastern side by Hempstead Road (odd number side only) from the Town Hall to the Borough boundary; on the southern and western side by Rickmansworth Road (even number side only) to the Borough boundary; and on the western side by the Borough boundary comprising an area of 970 acres approximately.
