SOUTHERN RHODESIA

*The Southern Rhodesia (Prohibited Exports)
(Asbestos) Order 1966*

Made - - - -	3rd June 1966
Coming into Operation	4th June 1966
Laid before Parliament	4th June 1966

I, Michael Stewart, one of Her Majesty's Principal Secretaries of State, in exercise of the powers conferred on me by Article 3(2) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966, S.I. 1966/41 (1966 I, p. 64), hereby make the following Order:

1. This Order may be cited as the Southern Rhodesia (Prohibited Exports) (Asbestos) Order 1966 and shall come into operation on 4th June 1966.
2. Asbestos is hereby specified for the purposes of Article 1(1) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966.
